THAT the Council of the District of Ucluelet are of the firm opinion that fairness and equity require the payment of the \$1,000,000 debt that pre-dated the Priority Mortgagee, and fair settlement of interest given the District's forbearance of other remedies and cooperation with all parties to allow restructuring and sale of the Lands;

AND THAT District staff and/or Legal Counsel advise:

- The Monitor and the Court of further particulars concerning the Lands zoned CD-5A and CD-6, the Master Development Agreements and various Covenants that are presently in breach of required obligations, including a \$1,000,000 contribution to the District Amenity Reserve Fund that predated the Priority Mortgagee (collectively but not exclusively the "District's Interests");
- The Monitor, the Petitioners, Priority Mortgagees, Onni Group, 1019073 BC Ltd. and 1019074 BC Ltd. and their respective affiliates, that the District considers it has been unjustly treated given the timing of the proceedings during the known District office Holiday Closure, the lack of notice and the lack of identification of pertinent information to the Court in the CCAA Proceedings regarding the District's Interests;

- The parties who were invited to the Special Meeting of Council but did not attend, of Council's disappointment for their choice not to participate;

AND THAT District Staff and Legal Counsel are authorized to dispute, if deemed in the best interests of the District, any decision reached by the Monitor or Court that does not include prompt payment of property taxes and the \$1M amenity payment;

AND THAT District Staff and Legal Counsel are authorized to prepare and file a response to the Petition filed in the CCAA Proceedings, if deemed in the best interests of the District;

# RE: MORATORIUM TO ALLOW BCUC TO REVIEW PROPOSED SITE C PROJECT

In response to a report in our local paper, I recently attended the Powell River council meeting and made a presentation. As a result there was a unanimous decision to send a letter to Bill Bennett, Minister of Energy and Mines asking that there be a one-year moratorium on the building of Site C to allow the BC Utilities Commission (BCUC) to rule on the project.

I am aware that the District of Hudson's Hope sent a letter in December asking for support from municipalities regarding this issue. Unfortunately, the Province announced their approval of the project at the same time so many municipalities may have felt that it was too late to become involved. Although the Site C project has received approval, I believe that the BC Government should follow the recommendation of their Joint Review Committee and refer the issue to the BCUC before beginning construction.

Why is this a municipal issue? Almost everyone in BC uses electricity in their homes and their work places. Already ratepayers are bracing for 28% hikes over the next six years - and that is before the \$8.8 billion dollar costs for Site C are added. To date the provincial government has not acted on the advice of the Joint Review Commission\* so it is the responsibility of local government to act on behalf of its citizens. Raise your voices, write a letter to Bill Bennett and your local MLA to let the BC government know that it is their duty to allow BCUC to analyze the Site C project, thus ensuring that we all have affordable power in the future. Site C is reported to be the most expensive power project that British Columbia has ever embarked on so it is essential that the BCUC reviews the project before construction begins.

On December 2, 2014 we wrote to provide you with information regarding the proposed Site C Dam Project. We also sought your support for a one year moratorium to allow time to refer Site C to the BC Utilities Commission for independent review of the need, cost and alternatives to Site C.

The Province's December 16<sup>th</sup>, 2014 announcement that it has approved Site C only reinforces that need for independent BCUC review. For example, the capital-cost estimate for Site C has increased by almost \$1 billion dollars to \$8.8 billion.

Importantly, the Province has delayed the start of construction for six months until summer 2015. This allows time for additional consultation on construction permits, remaining Treasury Board approvals, and initial hearings of the 6 court challenges to Site C.

Clearly, it is open to the Province to delay construction for a further six months until winter 2015 to allow time for BCUC review.

This is the largest public infrastructure project in BC history. Local Governments, and the BC ratepayers and taxpayers we represent, should reasonably expect independent review of Site C by the BCUC.

We request an update regarding review of our December 2, 2014 letter and attachments and renew our request for a resolution supporting a one year moratorium and BCUC consideration of Site C.

Now that the November 2014 local government elections are complete, I am pleased to forward you a copy of our letter dated November 18<sup>th</sup>, 2014 regarding the proposed Site C Dam Project.

Site C would add about \$8 billion dollars to the provincial debt leaving the province with much less ability to contribute to important local government infrastructure projects in areas such as transit, water, sewer, and housing. Finance Minister Mike De Jong is quoted in the attached article as saying, "It [Site C] will likely crowd out many other projects."

The District of Hudson's Hope and the Peace River Regional District are calling on the BC government to place a one year moratorium on deciding whether to proceed with Site C. This will allow time to refer Site C to the BC Utilities Commission (BCUC) for an inquiry and public hearing into its economic effects, including potentially less costly alternatives. Adoption of a less costly alternative would free up provincial borrowing capacity to support important local government infrastructure priorities.

# Re: Referral of Proposed Site C Dam Project to BC Utilities Commission

I am writing in response to your letter dated October 31, 2014 received on November 12, 2014.

The District of Hudson's Hope, a community of 1,100 people in the heart of the Peace River Valley, will be more adversely impacted than any other municipality by the proposed Site C dam.

We have reviewed your letter and respectfully remain firmly of the view that the BC Utilities Commission should hold an inquiry and public hearing on the economic effects of the proposed Site C Dam Project ("Site C") prior to Executive Council making a final decision on Site C, especially in view of key recommendations #46 to #49 of the Joint Review Panel.

The Joint Review Panel noted in its report that it did not have the information and analysis to fully, properly and transparently assess the economic effects of Site C:

The Panel **cannot conclude on the likely accuracy of Project cost estimates** because it does not have the information, time or resources. This affects all further calculations of unit costs, revenue requirements, and rates. [Page 280]

The Panel concludes that, **basing a \$7.9 billion Project on a 20-year demand forecast without an explicit 20-year scenario of prices is not good practice.** Electricity prices will strongly affect demand, including Liquefied Natural Gas facility demand. [Page 287]

The Panel concludes that **demand management does not appear to command the same degree of analytic effort as does new supply**. [Page 291] The Panel concludes that **methodological problems in the weighing and comparison of alternatives** render unitized energy costs only generally reliable as a guide to investment...Uncosted attributes such as the ability to follow load, geographical diversity, or the ability to assist with the integration of intermittent sources need more analytic attention. [Page 298]

The Panel concludes that a **failure to pursue research over the last 30 years into B.C's geothermal resources** has left BC Hydro without information about a resource that BC Hydro thinks may offer up to 700 megawatts of firm, economic power with low environmental costs. [Page 299]

The Panel concludes that the Proponent has **not fully demonstrated the need for the Project on the timetable set forth.** [Page 306] [emphasis added]

As a result, Hudson's Hope, along with other participants in the Joint Review Panel public hearing, did not have an opportunity to review key information and analysis on Site C's economic effects.

The federal/provincial agreement governing the environmental assessment of Site C and the Panel's terms of reference highlight the importance of:

- (a) thorough review, and
- (b) meaningful participation of the public and interested groups through a public hearing,

to achieve a full, proper and transparent assessment of Site C.

Since the Joint Review Panel's release of its report on May 1<sup>st</sup>, 2014, interested parties including BC Hydro, the Ministry of Energy and Mines, other provincial government ministries and agencies, KPMG, the District of Hudson's Hope, and Clean Energy BC have prepared, or are preparing new information, analysis, reports, studies, forecasts and research ("New Material") in an effort to address the above concerns and recommendations of the Joint Review Panel. This New Material includes further examination of potentially less costly alternatives to Site C and the implications of Site C for the province's triple-A rating which has been given a negative outlook by Moody's.

However, unlike previous information and analysis on the environmental, economic, social, health and heritage effects of Site C, this New Material has been largely kept confidential. Most importantly, the New Material has not been the subject of independent and expert assessment and a public hearing as the terms of reference of the Joint Review Panel would have required. It is clear that further analysis of Site C is needed before Executive Council makes a final decision. As recently as November 13<sup>th</sup>, 2014, the Select Standing Committee on Finance and Government Services unanimously agreed that further fiscal and environmental review of Site C was needed. The issue is whether that additional analysis should include independent and expert review and a public hearing.

We continue to believe that the BC Utilities Commission ("BCUC") offers the best avenue for further independent, expert review and a public hearing regarding the economic effects of Site C. A review under section 5 of the *Utilities Commission Act* could be structured in a way that addresses all of your stated concerns with a BCUC review.

The Task Force conducting the independent review of the BC Utilities Commission highlighted the efficacy of the section 5 review approach<sup>1</sup> in their October 2014 interim report:

This [section 5] provides the **benefit of a public process and independent verification of projects and plans** but reserves the final decision on plans and projects that have broader public interest criteria to be decided by elected officials. [page 37] *[emphasis added]* 

We are enclosing draft section 5 terms of reference to illustrate how a BCUC review could be structured. Please note:

- The final decision on Site C still rests with Executive Council,
- BCUC is given a deadline of November 30, 2015 to complete its work<sup>2</sup>,
- The BCUC review is focused on new information and analysis regarding the economic effects of Site C to minimize duplication of previous assessment work, and
- Funding could be set aside by BC Hydro<sup>3</sup> or the BC Government in 2015/2016 to ensure BCUC has the necessary resourcing to complete this work in a timely manner.

Site C is estimated to cost \$7.9 billion which would make it the largest provincial public expenditure of the next 20 years. It is essential to public confidence in Executive Council's final decision on Site C, that a full, proper and transparent assessment of New Material on the economic effects of Site C is conducted. Further, that the assessment and analysis should come through an inquiry and public hearing, just as there was for previous information and analysis on Site C.

Broader use of section 5 is similar to the approach taken by the Federal government in its recent amendments to the National Energy Board Act. These amendments redefined the role of the Board, which is now mandated not to decide on applications for pipeline certificates, but to instead make a recommendation to the Federal Cabinet.

Section 5 requires the BCUC, on Cabinet's request, to provide advice on any matter regardless of whether it is in the Commission's jurisdiction. Section 5 also allows Cabinet to issue Terms of Reference for the inquiry. This provides the benefit of a public process and independent verification of projects and plans but reserves the final decision on plans and projects that have broader public interest criteria to be decided by elected officials.

For a project of this size and importance, we agree with the independent Joint Review Panel – the proper course of action is to refer Site C to the BC Utilities Commission.

In closing, we formally request that Executive Council

- 1. Place a one year moratorium on deciding whether to proceed with Site C, and
- 2. Refer the economic effects of Site C to the BC Utilities Commission for an inquiry and public hearing.

I request an opportunity to meet with you to discuss this letter before Executive Council decides whether or not to proceed with Site C.

### DRAFT TERMS OF REFERENCE

## IN THE MATTER OF the Utilities Commission Act (the Act)

#### and

# IN THE MATTER OF an Inquiry under Section 5 of the *Act* relating to the Site C Clean Energy Project

## BACKGROUND

- 1. British Columbia Hydro and Power Authority (the "Proponent") proposes to develop and operate a third dam and hydroelectric generating station on the Peace River in northern British Columbia which would provide up to 1,100 MW of capacity and about 5,100 gigawatt (GWh) of energy each year (the "Project").
- 2. The Project is estimated to cost \$7.9 billion which would make it the largest provincial public expenditure of the next 20 years.
- 3. In August 2013, the federal and provincial governments named a Joint Review Panel (the "Panel") to conduct an independent and expert assessment of the environmental, economic, social, health, and heritage effects of the Project.
- 4. The federal/provincial agreement governing environmental assessment of the Project and the terms of reference for the Panel (the "Panel Terms of Reference") required the Panel to hold a public hearing in order to provide opportunities for timely and meaningful participation of aboriginal groups, the public, governments, the Proponent and other interested groups (the "Participants") in the assessment of the Project.
- 5. The Panel Terms of Reference provide that the objective of the public hearing is to provide the Panel with relevant information from Participants, in a fair manner, to enable the Panel to conduct a thorough and timely review of the Project.
- 6. A public hearing conducted in accordance with the principles of procedural fairness inherently contributes to a full, proper and transparent assessment of the Project.
- 7. The Panel Terms of Reference require the Panel to consider the economic effects of the Project including:
  - (a) the need for the Project,
  - (b) alternatives to the Project,
  - (c) the economic effects of the Project,
  - (d) the significance of the economic effects of the Project,
  - (e) the value of electricity generated by the Project,
  - (f) initial capital construction cost and operating cost estimates,
  - (g) impacts on government revenue, and

(h) impacts on gross domestic product.

(the "Economic Effects")

- 8. The Panel Terms of Reference require the Panel to prepare and deliver a Joint Review Panel Report on the Project (the "Report") to the federal and provincial government who in turn are required to publish the Report.
- 9. On May 1<sup>st</sup>, 2014, the Panel delivered its Report to the federal and provincial government and the Report was published.
- 10. The Panel did not have the information, analysis, reports, studies, forecasts, and research to fully, properly and transparently assess the Economic Effects of the Project. In its Report the Panel notes:

"The Panel cannot conclude on the likely accuracy of Project cost estimates because it does not have the information, time or resources. This affects all further calculations of unit costs, revenue requirements, and rates." [Page 280]

"The Panel concludes that, basing a \$7.9 billion Project on a 20-year demand forecast without an explicit 20-year scenario of prices is not good practice. Electricity prices will strongly affect demand, including Liquefied Natural Gas facility demand." [Page 287]

"The Panel concludes that demand management does not appear to command the same degree of analytic effort as does new supply." [Page 291]

"The Panel concludes that methodological problems in the weighing and comparison of alternatives render unitized energy costs only generally reliable as a guide to investment...Uncosted attributes such as the ability to follow load, geographical diversity, or the ability to assist with the integration of intermittent sources need more analytic attention." [Page 298]

"The Panel concludes that a failure to pursue research over the last 30 years into B.C's geothermal resources has left BC Hydro without information about a resource that BC Hydro thinks may offer up to 700 megawatts of firm, economic power with low environmental costs." [Page 299]

"The Panel concludes that the Proponent has not fully demonstrated the need for the Project on the timetable set forth." [Page 306]

- 11. As a result, Participants in the Joint Review Panel Public Hearing did not have an opportunity to review key information, analysis, reports, studies, forecasts, and research necessary to a full, proper and transparent assessment of the Economic Effects of the Project.
- 12. The Panel made several recommendations to address the lack of a full, proper and transparent assessment of the Economic Effects of the Project:

### **RECOMMENDATION 46**

"If it is decided that the Project should proceed, a first step should be the referral of the Project costs and hence unit energy costs and revenue requirements to the BC Utilities Commission for detailed examination."

## **RECOMMENDATION 47**

"The Panel recommends that BC Hydro construct a reasonable long-term pricing scenario for electricity and its substitutes and update the associated load forecast, including Liquified Natural Gas demand, and that this be exposed for public and Commission comment in a BC Utilities Commission hearing, before construction begins."

### **RECOMMENDATION 48**

"The Panel recommends, regardless of the decision taken on Site C, that BC Hydro establish and research and development budget for the resource and engineering characterization of geographically diverse renewable resources, conservation techniques, the optimal integration of intermittent and firm sources, and climate-induced changes to hydrology, and that an appropriate allowance in its revenue requirements be approved by the BC Utilities Commission."

### **RECOMMENDATION 49**

"The Panel recommends that, if Ministers are inclined to proceed, they may wish to consider referring the load forcast and demand side management plan details to the BC Utilities Commission."

- 13. Since the Joint Review Panel Report was released on May 1, 2014, Participants including BC Hydro, the BC Ministry of Energy and Mines, other provincial government ministries and agencies, the District of Hudson's Hope, and Clean Energy BC have prepared, are preparing, or could prepare new information, analysis, reports, studies, forecasts, and research on the Economic Effects of the Project (the "New Material") in an effort to address the concerns and recommendations of the Joint Review Panel set out in paragraphs 10 and 12 above.
- 14. However, unlike previous information and analysis on the environmental, economic, social, health, and heritage effects of the Project, this New Material is largely confidential and has not been the subject of independent and expert assessment and a public hearing as the Panel Terms of Reference would have required.
- 15. On October 14, 2014, the Minister of Environment and the Minister of Forests, Lands and Natural Resource Operations issued an environmental assessment certificate to BC Hydro allowing the Project to proceed, subject to remaining authorizations including that of Executive Council, without addressing how to ensure a full, proper and transparent assessment of the Economic Effects of the project, and without addressing Panel recommendations #46 to #49.

- 16. Before Executive Council makes a final decision on whether or not to proceed with this \$7.9 billion Project, Executive Council wishes to ensure that New Material is the subject of an independent and expert assessment and a public hearing, and by doing so seeks to ensure that there is a full, proper and transparent assessment of the Economic Effects of the Project, including the matters referenced in Panel recommendations #46 to #49.
- 17. Section 5 of the *Act* provides that the Lieutenant Governor in Council may ask the BC Utilities Commission (the "Commission") for advice on any matter, and further that the Lieutenant Governor in Council may specify terms of reference requiring and empowering the Commission to inquire into the matter.

#### **REQUEST FOR ADVICE ON THE PROJECT AND TERMS OF REFERENCE**

NOW THEREFORE the Lieutenant Governor in Council requests the advice of the Commission on the Economic Effects of the Project pursuant to subsection 5(1) of the *Act* and specifies the following Terms of Reference for the Commission's inquiry into the Project pursuant to subsection 5(2) of the *Act*:


- 1. The purpose of this inquiry is for the Commission to make an assessment of the Economic Effects of the Project, including the matters referenced in Panel recommendations #46 to #49.
- 2. The Commission must hold a public hearing in accordance with standard Commission policy and practice on the Economic Effects of the Project, including the matters referenced in Panel recommendations #46 to #49.
- 3. For the purpose of conducting this inquiry and public hearing, the Commission:
  - (a) must invite and consider submissions, evidence and presentations on the Economic Effects of the Project including the New Materias from any interested person, including without limitation, aboriginal groups, the public, governments, the Proponent, other utilities, power producers, ratepayer groups and other interested groups;
  - (b) must hold the public hearing in accordance with the Commission's Public Hearing Guidelines, except that the Commission will make recommendations to the Lieutenant Governor in Council rather than making determinations; and
  - (c) may use all of the powers provided to it under the Act.
- 4. The Commission must prepare a report and recommendations on its assessment of the Economic Effects of the Project, including the results of the public hearing and any implications of its assessment for the Project, BC Hydro ratepayers and BC taxpayers. The report must be provided to the Minister of Energy and Mines by November 30, 2015.
- 5. The Minister of Energy and Mines must publish the report within 10 days of receipt.

# Vaughn Palmer: On power, fork in the road is a dam dilemma

Site C vs. independent power producers, debt vs. multiyear contractual obligations

VICTORIA — As decision day approaches, the B.C. Liberals face two main choices to meet the province's future electricity needs, both controversial.

"I can tell you that we're down now to essentially two options, one of which is Site C and one of which is the independent power project option," Energy Minister Bill Bennett told reporters recently.

The first option would see BC Hydro construct a last-of-its-kind hydroelectric dam at Site C on the Peace River.

The second would entail Hydro contracting with private operators to build smaller-scale power projects — wind, run of river, perhaps biomass and geothermal — that would be scattered around the province.

In disclosing the final two options, Bennett tacitly confirmed that the Liberals have dropped

consideration of building either a new gas-fired generating plant or refurbishing the little-used thermal plant on Burrard Inlet.

Each of the two remaining options has its proponents and — no surprise, this being British Columbia — each also raises ferocious objections. Anything one might say on this file is debatable, including this statement.

The pluses for Site C, as the government sees them, are that hydro is the proven method of electrical generation in this province and it provides some of the cheapest rates on the continent. Once the construction cost has been paid out, hydro dams are reliable for the long-term and there's no need to estimate the future cost of fuel, as with a gas-fired plant.

For the Liberals, independent power projects have their good points too. "I don't think there's any issue around the reliability of the independent power industry," Bennett told reporters. "It's a good industry. We're actually very proud to have it. We get 25 per cent of our electricity today in the province from the IPP industry."

The industry, in a recent analysis (the one prepared, then withdrawn by KPMG), cited some other advantages of smaller-scale projects over the all-or-nothing aspect of Site C. IPPs could be phased in over time and spread around the province. Hydro could contract for range of power sources, including unproven-for-B.C. options such as geothermal.

Bennett, for his part, insists that the deciding factor between the two options should be the impact of each on future electricity rates. "We have to make a decision here that will have implications for many, many decades to the people who live in the province, to the businesses that operate here. We have to try to do everything we can to keep rates down, and that's the basis upon which we'll make this choice."

But having seen competing analyses on that score over the years, I doubt there's an indisputable answer to the question raised by Bennett. It all depends on the assumptions one makes going in and going forward.

Besides, other considerations have to be weighed, including the veto-in-all-but-name that First Nations exercise over resource development in this province.

One advantage for independent power involves the emerging role in such projects for First Nations as partners, developers and suppliers of services. By comparison, natives in the Peace River region have mounted a strong legal case that Site C would cause irreparable damage to aboriginal rights, title and interests.

Another factor is the impact on the provincial debt. IPPs don't entail a lot of provincial borrowing. They are underwritten in large measure by long-term contracts, which by verdict of the independent auditor general (applying generally accepted accounting principles) are listed in the public accounts as \$56 billion-and-counting worth of multi-year contractual obligations but not as debt.

Not so with BC Hydro. Because of the corporation's already hefty debt load, and the government's practice of raiding its accounts for dividends, the giant utility will have to borrow much of what it estimates to be the cost of Site C, namely \$8 billion.

The province is already constrained in how much more it can borrow, according to Finance Minister Mike de Jong. "I don't think we have a lot of room to move at this point," he told me during an interview Thursday on Voice of B.C. on Shaw TV.

"Those rating agencies that assess us increasingly look at other variables and other measures ... The distinction that has historically been made by these agencies between taxpayer-supported debt and the debt incurred by agencies like BC Hydro, which is self-supporting, is beginning to blur in the minds of some of these bodies. So I'm saying we have to be cautious."

Plus if Hydro is green-lighted to borrow billions for Site C, there will be that much less borrowing room for everything else. "It will likely crowd out many other projects," de Jong continued.

Not to say that debt-loading or First Nations will trump all other considerations. Only that when the Liberals say this is one of the toughest and most expensive decisions they've faced, they mean it.

As to timing, Premier Christy Clark told reporters Thursday that BC Hydro, as proponent for Site C, is pressing for a "yes" by the end of the year in order to take full advantage of the 2015 construction season.


But she also left open the possibility that the decision, being contentious, could spill over into next year.

Concerns: Council Decision of December 9<sup>th</sup> 2014: Proposed Zoning Amendment 1176, 2014

-<u>**Rejection**</u> of application to re-zone Lot #20 Section 21 Clayquot District, Plan VIP64737,PID 023-656-107, from R-1 Single Family Residential to R-1 Vacation Rental.

On December 9<sup>th</sup> 2014 the Council held a public inquiry into the above re-zoning application and, after hearing objections from owners of neighbouring properties, then **unanimously rejected the application**.

Matters have since come to light which require urgent remedial action by the District to ensure compliance with Council decision.

This letter informs the Council that:

- Although the application was lodged as a request to operate vacation rentals from the premises in the future ("We ideally would love to turn our 1 bedroom suite into a nightly rental"), in reality, the property had already been advertised widely as available for nightly rentals. So far, we have located 15 current websites with advertising particulars; several of them are dated as <u>opened</u> <u>AFTER the Council decision</u>. Bookings are traceable after the Council decision and already extend into May. All this without a business licence, we must presume. (copies of website pages are attached, as well as a list of the internet addresses).
- The owners told the District in their application they wanted authorisation to rent out a 1-bedroom suite. In reality, websites refer to two units and accommodation available for nightly rental for <u>up to 6 people (indeed, perhaps</u> <u>8 people</u> – see next point, 3) below).

- 3) Most websites indicate that a <u>cabin in the garden</u> has been <u>transformed into</u> <u>sleeping accommodation</u>, additionally available for rental (sleeps 2). The siteplan that accompanied the application to the District (doc L-2.9) indicates only a shed in the garden. If this is indeed the "cabin", it is a matter for conjecture whether this structure benefits from the occupancy permit issued for the property.
- 4) The Council will doubtless also wish to verify that use of the "cabin" for sleeping accommodation would be fully in accordance with applicable building standards, health & sanitation requirements and fire precautions, not to mention advisable standards on tourism service provision.
- 5) Further, according to the aforesaid siteplan, there are grounds for believing that such "cabin" may have **a basic impediment as allowable structure**, since one entire wall and parts of two other walls are shown closer to the neighbouring property than the 1.5m required setback.
- 6) Some of the publicity egregiously mentions that parties are free to use **a fire pit** in the small back garden, though this directly adjoins forest land owned by neighbours. Holidaymakers are informed that they would be only "steps away from the ocean", neglecting to mention that any such steps would be **unlawful trespass** on other people's property.

We, the undersigned neighbouring property-owners, are most disturbed by these matters. The house on Lot #20, by formal decision of the Council, cannot be used for any purpose other than as a single family dwelling. Should publicity continue by the owners, or by agents on the owners' behalf, to tout the property for nightly rentals, such action can only be interpreted as formal refusal to accept application of Council by-laws.

The aspect of unauthorised use of buildings (be it main house or shed) could additionally have a bearing on the validity of **property insurance**. This is not purely an issue for the financial wellbeing of the owners. There is always the potential for claims arising from accidents to people in the property, or from neighbours (in the case, for instance, of fire spreading). An insurance company expects that a building and the terms of its occupancy be in compliance with known legal requirements. Should there be a case where nightly rentals proceed in flat denial of the Council's decision, a business without business licence, it would be interesting for insurance lawyers. Likely, they would consider the contract voided. Should any tourist be caught into this, it would not be to the advantage of Ucluelet's reputation. If any claims arise, the District's role, as fully informed party, would not go unexamined.

While on the issue of whether the building or parts of it are fit for purpose, we also respectfully remind the Council of <u>questions that were raised on December 9<sup>th</sup></u> last. <u>They are repeated below</u>. Has action been taken or will it be?

1. <u>Driveway</u> On page 5 of Schedule H (Schedule of Restrictions), Clause 5 states: "Each lot will be permitted to clear one only five (5) meter strip for a driveway connecting the dwelling to the subdivision road."

The Subject property appears to have two cleared driveways, as per their drawing L-2.9, one from the road to their garage, and the other on the District of Ucluelet's 7.5 meter front yard setback at the front of the house.

2. <u>Sideyard</u> The Plan Drawing of the Subject property indicates that the footprint of the house achieves the 1.5 meter sideline setback required by District Bylaw No. 1160, 2013 R-1.6.1

The footprint, however, does not achieve the provision stated in R-1.6.2: "In addition, the side yards combined must not be less than 20% of the lot width". Lot 20 is 18.434 metres wide. According to L-2.8 the structure is 16.154 metres (53 feet) wide, but the maximum allowed width of the structure is only 14.747 metres (80% of the lot width). A site certificate prepared by a licensed surveyor could well clarify whether the building on Lot #20 (including the shed or "cabin") is correctly sized and in order or not.

However, the <u>immediate point is that the District intervene with appropriate and sure</u> <u>measures to ensure that its own decision is respected</u> and that tranquility is restored to the neighbourhood. No vacation rentals must occur. Action of a `<u>cease and desist</u>` nature is required to <u>halt and remove publicity</u> and avoid a build-up of bookings which otherwise would start from now on, moving towards Spring. Needless to say, we reserve our full rights in law should there be no satisfactory and rapid outcome to our request.

This whole case has caused more disturbance than could reasonably have been anticipated. And it leaves two nagging questions, that perhaps can be considered with calm, later, namely whether:

- a) the Council's procedures, and notably due diligence, on zoning applications and property use could be subject to some revision. All the information above, which we as neighbors have obtained with a little research, was equally available to the District's own services, but none seems to have been used in the processing of the application and evaluation of its merits. It is more than ever surprising that the services were prepared to nod this application through, apparently with such partial understanding.
- b) now may be the time to re-appoint a By-laws Enforcement Officer, a position that existed until quite recently, but which for some short-sighted reason the previous Council did not maintain (although we understand three members of the District staff are authorised to do this, namely Andrew Yates, Patricia Abdullah and Warren Cannon). Ucluelet has expanded and matured these recent years, attracting significant investment, especially in homes. The town development plan calls for much more. The first things investors/home owners seek are predictability, that rules work (West, but not wild west); the last things they want to perceive are "blind eyes", looking the other way, suspicion of opaque favors. That would be very much to the detriment of Ucluelet. In prioritising District expenditure, enforcement of by-laws certainly should not rank last.

The subject site is zoned CS-5 Tourist Commercial. The side yard setbacks required in this zone are 10'. After the original area subdivision and rezoning, a subsequent strata subdivision was approved. It does not appear that the zoning setbacks were taken into account at that time. Two ten foot side yard setbacks for this strata property significantly reduce the width of a structure on this property. Should Council direct, staff would prepare a future report with a proposed amendment to the CS-5 zone for lesser side yard specifically for those strata properties of a smaller lot size.

#### Staff Note to Council:

*February 10, 2015* 

The subject site is zoned CS-5 Tourist Commercial. Neither Zoning Bylaw #800 nor the current Zoning Bylaw #1160 permitted residential uses in the CS-5 although it does permit some Commercial Tourist Accommodations defined as "the non-residential, daily or short term (not exceeding 30 consecutive days) accommodation of paying guests, transient motorists, tourist or vacationers, as commonly associated with hotels, motels, resorts, vacation rentals, guest houses, hostels, bed and breakfasts and campgrounds." This is the default maximum number of days for a Non-Residential use. This maximum number of days may be amended in a Zoning Bylaw and this was a point of discussion through the review of the recently consolidated Zoning Bylaw. Council, at the time, determined to leave the maximum default number of days in the bylaw stating its potential greater impact dependent upon the zone in which the non-residential use occurred. They deferred it for a future staff review and public survey and input in 2015. Should Council direct, staff could initiate the public input and survey and bring back a further report for recommendations.

We are parents of 3 children; a son and 2 daughters.

We are compelled to write civic leaders in our local areas about the issue of human trafficking amongst our youth. We are writing to 22 municipalities.

We have homes in North Vancouver and Ladysmith/Nanaimo. One daughter lives in Squamish working at Whistler. Our son worked for MP Mrs. Joy Smith (St. Paul/North Kildonan, Manitoba). She is Canada's human trafficking/ child exploitation expert.

Joy Smith brought in our first human trafficking laws (Bill C-268 and Bill C-310).

The Federal government has now acknowledged the significantly growing (and very lucrative) human trafficking problem in Canada with the passage of Bill C-36 (December 2014).

Rich Akins of the Vancouver Police Department says there is human trafficking in every community. As an example, in September, 29 year old Reza Moazami was charged with BC's first human trafficking conviction. He comes from North Vancouver and trafficked 11 girls (9 underage) from condos/hotels in North Vancouver, Vancouver, Richmond and Nanaimo. RIGHT UNDER OUR NOSES!

For a summary on human trafficking I have included a link to my 10 minute presentation on October 6, 2014 to Nanaimo City Council.

My notes and references are included in the attachment. Please use any of this material to learn about the topic and pass on to other municipal, provincial, federal leaders, business people, educators, police, social workers, etc. Education is our greatest weapon.

We would appreciate your comments. Please let us know how you are addressing human trafficking in your area. Municipalities inadvertently support this illegal activity by giving business licenses to casinos, massage parlours, nail spas, escort services, strip clubs, etc. which can be common covers for human trafficking, For the sake of our children, grandchildren and the future of this country, please learn as much as you can about human trafficking so that together we can STOP IT.

#### TEN MINUTE PRESENTATION:

#### Nanaimo City Council- October 6, 2014

#### Introduction:

My name is Cathy Peters, and I am speaking on behalf of my husband, Allan and myself. We have recently moved to this area. Allan is an architect and I am a retired high school teacher. We are the parents of 3 children, a son and 2 daughters. Our son, worked for MP Joy Smith, in Ottawa, who is Canada's leading expert in human trafficking and child exploitation.

We are here today to speak to the issue of human trafficking, or sex trafficking. We want to alert local politicians and civic leaders to this rapidly growing problem.

We have sent this council and the Nanaimo School Board (as well as 12 other municipalities and 1 other School Board) numerous emails on this issue.

We moved to this area because we see the tremendous potential in this City. You have the best weather in the country. Nanaimo is beautifully and centrally situated on spectacular Vancouver Island. It is an ideal service center for the rest of the island. It is the gateway to fabulous Long Beach/ Tofino and the exquisite wild west coast. This city offers a fantastic, healthy, and affordable lifestyle.

Focus on service, focus on eco-tourism, focus on all that is beautiful and good, so that you have a dynamic, vibrant, healthy community. Your downtown, for example, has the potential to be charming, unique and delightful. We love exploring the winding streets with intimate coffee shops, eateries, art galleries, book stores. Tree lined boulevards, and a climate that allows for gardening and sports all year round, Nanaimo has it all.

#### Will you recognize and foster these qualities?

Human trafficking is alive and well on Vancouver Island and in Nanaimo. As I recently emailed you, (September 17) BC has just made its first human trafficking conviction: 29 year old Reza Moazami from North Vancouver was pimping out 11 girls, 9 of them underage. He had these girls sexually servicing men from hotels and condos in North Vancouver, Vancouver, Richmond and Nanaimo. Under our noses.

According to Vancouver police officer, Rich Akin, human trafficking is happening in every community in BC.

**Definition:** Human trafficking is the recruiting, transporting, transferring, receiving, holding, concealing, harbouring or exercising control over a person for the purpose of exploiting them.

#### Facts about Prostitution and Sex Trafficking:

Human sex trafficking is the fastest growing crime in the country and the world.

People everywhere in this world are being bought and sold like merchandise. Men, women, children.

Today's new slavery has low costs and huge profits. In Canada, a pimp, trafficker or predator will earn about \$280,000 per year, per victim. The average pimp will have 4-5 girls working for him as prostitutes.

In Canada the average age of entry into prostitution is 14-16 years of age. For aboriginal girls it can be as young as 7-11 years old. The vast majority (89-98%) of prostituted women are lured, tricked or trafficked into prostitution. **It is not a choice.** 

92% of prostituted women would quit immediately if they could. It is easy to enter prostitution and very difficult to get out.

85% of the prostituted were sexually abused as children.

Aboriginal women are grossly overrepresented in prostitution and trafficking.

Trafficking of girls and women is driven by the demand to buy sex. The internet is fueling this demand through pornography. Pornography creates sexual appetite, and this causes a dramatic demand for sexual services. Result? The supply has to increase. Where does this supply come from? Local girls and women are now being targeted here in Canada to satisfy the rapidly growing demand for paid sex.

In the countries where prostitution is legalized: the Netherlands, Germany, Australia, New Zealand, human trafficking has exploded. We as parents we never want prostitution legalized in this country. How about you?

(Just a point: since we have such a long border with the USA, if we ever legalized prostitution, Americans would come to Canada in huge numbers for sex tourism.)

(And another point: the pro-prostitution lobby say prostitution can be safe with appropriate employment laws. Employment laws do not apply to prostitution because prostitutes are "independent contractors" and do not fall into traditional employer/employee roles).

The magic trio: wherever there are drugs, gangs and prostitution, there is trafficking.

RCMP estimate 15,000-20,000 missing children in Canada currently per year. This is considered a conservative estimate. These children are probably trafficked.

#### Who gets trafficked and how does it happen?

Young people are vulnerable because they want a better life, they are lonely, they desire love and attention, they are mad at their parents! Pimping and prostitution is shown as glamorous. Ads suggest that young women work at strip clubs to pay for university.

Anyone can be trafficked: your parents, sister, brother, daughter, son, friends, grandchildren, neighbours, the girl next door.

#### How do traffickers get their victims?

They recruit anywhere- typically targeting young vulnerable girls. At schools, malls, parties, the internet, bus stops, train stations, ferry terminals, airports, on the street, libraries, through family members, boyfriends, girlfriends.

They lure by pretending to be their boyfriend. Girls fall in love with their pimps. Initially, the girls are treated like princesses and are introduced to a glamourous lifestyle.

Then, they are isolated from family and friends. The control begins. Threats, intimidation, violence, ID is taken from them, degradation begins, dominance, threats against victim's family if the victim tries to leave or does not cooperate. There is starvation and sleep deprivation. Addictions begin.

Victims develop the Stockholm Syndrome or trauma bond. They cannot see any way out. If they are underage, they are robbed of their childhood and robbed of all dignity and sense of value and worth as human beings. To their core, they come to believe that they are absolutely worthless.

Prostitution is linked with organized crime. It is not possible to work in the sex industry without being involved in some way with the criminal element. Prostitution is linked with trafficking and inherently very dangerous and violent. As

pornography gets more and more violent, johns demand the same services that they have viewed, from the prostitute. Johns prefer younger and younger women. Exited prostitutes report that they made their most amount of money when they were young and underage.

#### STRATEGIES TO END HUMAN TRAFFICKING:

We request that the Nanaimo City Council have specific goals to stop human trafficking and sexual exploitation that is occurring in this city.

Begin by learning as much about the topic as possible. Have all staff/councillors take the BC OTIP Human Trafficking Awareness Online Course offered by the Provincial Ministry of Justice. (It is free and takes about 7 hours to complete). Then, ask the Justice Ministry to address this issue in more depth and to come up with a province wide strategy to deal with the problem.

Have strong supportive liaisons with area RCMP and provincial and local social workers/youth workers as well as the local School Board.

Coordinate education and prevention activities in the school district, using materials and resources from the BC governments Human Trafficking coordination center. Also utilize materials from the RCMP human trafficking kit.

Work closely with the local Health Authority, collaborate and train together on this issue. (The Fraser Health Authority is the most pro-active in this area in BC. Contact them for their strategies.)

Read Dr. Gail Dines research on pornography. She is the world's expert and has written the bestseller book "Pornland". Porn is fueling the sex industry.

Address the issue with surrounding towns and municipalities. At the provincial municipal annual conference make a motion to study and address human trafficking in BC in order to stop it.

Declare human trafficking awareness day- Feb. 22 (this corresponds with Feb. 22, 2007 the day the House of Commons unanimously declared human trafficking a crime that must be stopped and prevented in Canada).

Put together a task force of 10-15 people (ie. doctor, police, social worker, educator, city councillor etc.) to create a strategic action plan to deal with human trafficking in the next 1, 3 and 5 years.

This council can be a role-model for other municipal councils. Encourage the Provincial government to form a task force to address human trafficking.

With a strategic action plan in place, approach the Federal government and apply for some of the \$20 million dollars being set aside to stop human trafficking and exploitation of persons. Ask the Provincial government to match funds. Ask NGO's and private sector to match funds.

#### What parents can do to protect their children:

Educate yourselves about the issue.

Take the BC OCTIP Human Trafficking Awareness Online Program offered for free by the BC Ministry of Justice.

Research anti-trafficking organizations in this community. Get involved with the human trafficking/sexual exploitation issue by supporting organizations who are addressing it; volunteer, fundraise, lobby on their behalf.

Watch videos, for example: Hope for the Sold's documentaries' "Enslaved and Exploited" and "Red Light Green Light". Shared Hope International documentary, "Chosen". Documentary "Nefarious". Documentary "Buying Sex".

Educate your children. Pimps and predators will recruit children as young as 10 years of age.

Monitor your children's outings: Are they with a trusted adult? Are they alone?

Know your children's friends.

Watch your daughters, specifically for older boyfriends. Older boyfriends can be pimps who do not kidnap, but who manipulate.

Internet safety- There are websites to help parents protect their children. Children need to understand the danger of posting pictures online. These photos can put children at risk.

Have open communication with your children and build bridges of trust and unconditional love for your children.



Canada Post has announced a plan to:

# **1. Attack the public postal network.**

Canada Post plans to use more private post offices while streamlining the public postal network. This means closing and downsizing public post offices, as well as reducing their hours. Canada Post has closed about 40 urban and 75 rural post offices since 2012. This is the largest number of closures we have seen since the Conservatives closed about 1,500 rural and urban post offices in the eighties and nineties. More closures are expected. The corporation is also reviewing all urban offices to see if they can be made smaller and operated with fewer workers. In addition, it is dramatically reducing hours of service in rural communities.

# 2. Introduce huge postage rate hikes.

On March 31, 2014, the price of buying one stamp increased by 59% while the price of buying a book or coil of stamps increased by 35%. The price for pre-sorted and incentive letters increased by 15% and metred mail increased by 19%. These sudden and dramatic increases are unfair, unreasonable and bad for the corporation's business. It would have been wiser and more reasonable for Canada Post to adopt gradual increases to keep up with rising costs.

### 3. Make our country the first in the world to eliminate doorto-door delivery.

Canada Post plans on taking away doorto-door delivery from over five million Canadian households and replacing it with community mailbox (CMB) delivery. There is a great deal of opposition to this plan, which will create huge problems for many Canadians, especially seniors and people with mobility issues. According to a recent poll, sixty per cent of people oppose the delivery cuts. In spite of this, Canada Post is determined to wipe out home mail delivery within a five year period. So far, Canada Post has announced its plans to convert more than a million households. The bulk of conversions will occur after the 2015 federal election. The federal government fully supports this major cut to public postal service.

# 4. Destroy 6000 to 8000 decent jobs.

Canada Post would need fewer employees if it goes to community mailbox delivery. It expects to eliminate 6000 to 8000 positions. Closing and downsizing post offices and reducing post office hours will also reduce the number of jobs in communities throughout the country. Our communities and our economy cannot afford to lose thousands of decent paying jobs.

# The future of Canada Post

Canada Post and the Conservatives should consult on their plan to change public postal service as we know it. The public owns Canada Post. They have a right to input. This has not really happened in any meaningful way. Canada Post engaged in some discussions, but they were completely inadequate. The corporation held inviteonly meetings in 46 communities and conducted a largely online public consultation on its future, focusing on cut. Since this time, over 400 municipalities and municipal organizations have passed resolutions or sent letters protesting the cuts or asking for a halt until there is meaningful consultation. Moreover, many thousands of Canadians have signed petitions and sent messages to their Members of Parliament (MPs). People have asked their federal representatives to tell Canada Post to stop the cuts and consider alternatives such as postal banking. Cutting might help Canada Post with its money problems in the shortterm but it is not a good long-term strategy and it certainly won't improve the future of postal service in our country. The corporation should be following the lead of other postal administrations by innovating and introducing new revenue-generating services.

## **Postal banking**

The Canadian Union of Postal Workers (CUPW) believes that our country needs improved financial and banking services and that Canada Post is well placed to fulfill this need. Moreover, the union thinks that adding financial and banking services at Canada Post will help the corporation preserve public postal service and generate revenue. CUPW is not alone. Close to two-thirds of Canadians support Canada Post expanding revenue-generating services like bill payments, insurance and banking, according to a poll from April 2014. Many municipalities like the idea too. About 600 municipalities have passed resolutions endorsing the addition of financial and banking services at our public post office. Not only that, three former Canada Post Presidents have spoken favourably about the corporation getting more involved in financial services (i.e. Michael Warren, Andre Ouellet and Moya Greene). In recent years, Canada Post has even conducted studies on postal banking that appear to indicate that getting into financial services would be "a win-win strategy" and a "proven money-maker" for the corporation. This positive assessment was obtained through an Access to Information (ATI) request. Unfortunately, 701 of 811 pages of the ATI request were redacted. To date, Canada Post President Deepak Chopra has refused to release the 811 pages in their entirety.







#### **Keynote Speaker**

Tonia S. Winchester Deputy Campaign Director Washington State Initiative 502

Marijuana legalization is an important topic facing Vancouver Island and its surrounding communities. With Washington state just across the border implementing a state-wide recreational marijuana system and the launch of the MMPR, Canada's nationwide medical marijuana mail-to-order program, the issue is even more pressing. What are the challenges of implementing full legalization, and how should communities start addressing the topic? What worked in Washington State, and how does

the current system in Canada actually operate? Tonia will provide an overview of the Washington state campaign, the current MMPR model, and will answer your questions about what your community needs to be thinking about as you approach the Canadian federal elections this year.

Tonia is a former Seattle Prosecutor who worked as Deputy Campaign Director, Washington State Initiative 502 that successfully legalized marijuana in Washington State by a 56-44 margin in November of 2012. Her role included forging alliances and getting endorsements from many groups traditionally seen as hostile to marijuana reform, as well as speaking across the state advocating for a new approach to Washington State's marijuana laws.

Most recently Tonia led the initial operational team that established and managed the Tilray medical marijuana production facility in Nanaimo, British Columbia - one of the largest medical marijuana production facilities in all of Canada. Tonia continues to speak across both the US and Canada advocating for the responsible and regulated legalization of cannabis, as well as working to help ethical and progressive businesses get established within the cannabis industry.

Tonia received her B.A. from the University of Washington and graduated cum laude from Seattle University School of Law.

The \$606.2M North Island Hospitals Project (NIHP) is the largest project that Island Health (VIHA) has undertaken to date. This Public-Private Partnership approach will provide new and expanded infrastructure that will ensure enhanced quality and safety, greater efficiency, flexibility, adaptability, and maximum recruitment and retention potential for Island Health. The NIH Project is responsible for the building of a new \$331.7 million, 153-bed Comox Valley Hospital and a new \$274.5 million, 95-bed Campbell River Hospital, both slated for completion in late 2017.


Along with major innovations in building design and technology, the project is also unique in the efforts placed on community consultation and information sharing

through quarterly community information sessions, the formation of a Public-Patient Advisory Committee, an Aboriginal Working Group, and design team consultation with clinical user groups. NIHP has been recognized by the Canadian Council for Public-Private Partnerships for innovation and excellence in public-private partnerships receiving the Silver Award for Infrastructure Sustainability. Nearly 90% of the total employment on both sites to date is from Vancouver Island.

Chief Project Officer Tom Sparrow will provide delegates with personal insight and lessons learned showcasing some of the unique demands placed on the municipalities and outline the processes to assist municipal leaders and staff with regards to effectively managing those demands when large infrastructure projects of this scope and magnitude are introduced into their communities. The delegates will be able to watch construction taking place at the Comox Valley Hospital site from the safety of their tour bus and see/speak directly with clinical and technical project team representatives about key clinical rooms that are in the final stages of design.

Since opening in 2011, the Vancouver Island Visitor Centre in the Comox Valley has been welcoming locals and visitors alike. Delegates will tour the award-winning facility and exhibits.

# Why Municipal Support is Necessary: Building Strong Communities Through Affordable Housing

With greater proportions of our population living in core housing need (221,470 of British Columbia households in Core Housing Need in 2006 and 23% of all British Columbia households are paying more than 50% of their income on rent in 2014), compounded by limited funds and shrinking federal government support for housing, non-profit organizations are experiencing increased pressure to service our vulnerable sector with inadequate support. This session is a push for action by local governments to positively utilize their planning power to advance affordable housing initiatives. This session will provide an overview of why effective collaboration between municipal governments and non-profits is necessary, and will highlight specific ways municipal governments can support non-profits in developing affordable housing. **Presenters:** *Kevin Albers, CEO and Kaela Schramm, Director of Projects and Planning, M'akola Development Services* 

#### Wastewater Treatment/Resource Recovery Advances

An advanced wastewater treatment facility, Sechelt's Water Recource Centre (WRC) is designed to process wastewater into dewatered biosolids suitable for composting and high quality effluent water suitable for a wide range of reuses. State of the art technology and innovation in design reduce both pollutant discharge and operating costs. With noise and odour minimization, a compact footprint and appealing design, the WRC is integrated into a park space that complements the adjacent nature reserve and residential community. Removal of hormones and pharmaceuticals from effluent water using biochar made from the biosolids is slated to be tested at the WRC in 2015. **Presenter:** *Paul Nash, Project Coordinator, Sechelt Water Resource Centre* 

#### Planning for Island-wide Intermodal Transportation

Whether the focus is rapid transit in Greater Victoria, container shipping in Nanaimo, LNG in Port Alberni, passenger/cargo rail, export capacity, BC Ferry schedules, new road proposals, airport expansions, public transit efficiencies, foot passenger ferries, peak session shipping capacity, or barging solid waste, it is time for a comprehensive intermodal transportation plan to turn what is widely viewed as an 'Island liability' into an economic advantage. Our panel of experts will engage your ideas as we work toward a prioritized plan to improve connectiveness, efficiency and accessibility.



# NETWORKING AND SOCIAL ACTIVITIES



#### PURPOSE:

To provide Council with information on a development permit application as required by Ucluelet's Official Community Plan. The Applicant proposes to add a 150 sqft north facing deck to a second storey residential suite on the subject site's principle multi use building (see Figure 1).




#### PREVIOUS DEVELOPMENT PERMIT AND LAND SUBDIVISION

The property was subject to a Development Permit (DP) dated March, 1992. Aspects of that DP appear not to have been met in regards to parking. That non-compliance is further complicated by a subdivision of the property on September, 2005 which removed the proposed parking lot area from the 1992 DP (see Figure 2).

The applicant has voluntarily worked with Planning staff to satisfy the 1992 DP parking requirement within the confines of Lot 1, Plan VIP 79663 through the current application.

### ZONING:

The subject property is zoned (CS-2) Service Commercial which allows for the current residential use which the proposed deck will be part of. The proposed deck addition meets all lot regulations, maximum density, maximum height and minimum setback requirements of the sites current zoning.

### PARKING:

The proposed deck does not require any additional parking.

### LANDSCAPING AND SCREENING:

The Deck addition will not drive any landscaping requirements on the subject site. The applicant is however currently landscaping the area around the 'Raven Lady'. This landscaping is of the proponent own volition and is on a separate lot to this development permit proposal.

### **DEVELOPMENT PERMIT GUIDELINES:**

The subject property falls within Ucluelet's, development permit Area #1 (Village Square) which establishes objectives for the Form and Character. The prime objective of the development permit designation is to ensure that development, whether new or the redevelopment of existing sites forms a positive impression and encourages a high quality of architectural and urban design. The Applicant has submitted a design package (Appendix A) to address the development guideline requirements outlined below.




Figure 4-Proposed

The Applicant is intending to modify the existing lower north facing roofline to include a second storey deck (see Figure 3 and 4)

The proposed deck, along with its materials, is consistent with the look of the existing building and consistent with the form and character guidelines for the Village Square DP area.

#### **SUMMARY AND CONCLUSION:**

The new deck will have minor impact to the overall experience from Peninsula Road and Bay Street. Planning staff consider the deck addition to be an increase in building permeability and will benefit the Peninsula Road streetscape.

As you are aware, the red roofed Burley building at Peninsula and Bay has been sold to an Alberta company, 307266 Alberta Ltd. (Bruce and Monique Schmaltz of Beiseker, Alberta.)

No strangers to the west coast, the Schmaltz family have made many trips here in recent years, holidaying on the Pacific Rim.

As appreciators of art and design, their fascination with the Burleys' Raven Lady eventually led to their purchase of the sculpture, the commercial building and the property at Peninsula and Bay.

The accompanying applications for a building permit and development permit, center around a minor alteration to the building and a reconfiguration of the open space on the Peninsula and Bay corner, as well as the creation of more parking spaces at the Larch end of the property.

#### **PURPOSE:**

To provide Council with information on the proposed rezoning of the subject property located at 542 Marine Drive **(Figure 1)**. The proposed Rezoning is from CD-2A, Single Family Dwelling to VR-1 Vacation Rental.

#### ANALYSIS:

The subject site is a 0.59 acre lot located on the west side of Marine Drive overlooking Big Beach Park and the Pacific Ocean. The immediate neighbourhood is a mix of Single Family Dwellings (SFD), SFD's with Vacation Rental units, Multi Family dwellings and Resort Condominium. To the south of the subject lot there are two VR-1 zoned lots that were previously zoned CD-2A. **(Figure 1)** 

The subject lot complies with the VR-1 lot regulations (VR-1.2). The proposed 750.5sqm (8078sqft) SFD will contain one 63.5sqm (684sqft) vacation rental unit. The vacation rental unit would be located over an integral garage in a purpose built SFD. The preliminary drawings meet the VR-1 zone, Section 406-Vacation Rentals and Division 500-Off-Street Parking requirements. It should be noted that if the property is rezoned to VR-1 the applicant is permitted to build within the VR-1 zoning regulations and that the applicant is not tied to the proposed building plans submitted. The property is affected by a statutory building scheme (EV154677) that do not involved the District, and are the property owner's responsibility to comply with.



- Show continued support from the District and council to improve the activity and energy levels of the community


