- Ministry of Environment Bear Smart Community Program
  - Council received a presentation on the Bear Smart Community Program from Crystal McMillan and Sergeant York, who noted that due to a communication error at the conservation office Ucluelet's previous application was not completed, which prevented Ucluelet from achieving Bear Smart status; it was also noted that in light of bears being killed this year in 2016, Ucluelet may wish to re-pursue Bear Smart Status, and that Bear Smart BC Consulting could assist with updating Ucluelet's previous application
