- 4% of the fees at the Dock's go to the Coast Guard Auxiliary.

CALL TO ORDER:

Chairperson Boysen called the meeting to order at 5:35 PM.

ADDITIONS TO AGENDA:

Addition of Agenda Item under New Business

- Fisherman's Dock & Fish Sales
- Update on Committees for 2019

APPROVAL OF AGENDA:

It was moved by Commissioner Kimoto and seconded by Commissioner Winpenny to approve the January 23, 2019 HAC agenda as amended.

MINUTES:

It was moved by Commissioner Kimoto and seconded by Commissioner Winpenny to approve the November 8, 2018 minutes as presented.

CARRIED

BUSINESS OUT OF THE MINUTES:

- Commissioner Kimoto questioned whether the old fish plants have been properly decommissioned, specifically the refrigeration units.
- CAO Boysen advised there is not currently an official inspection process in place at this time. However, the Ucluelet Volunteer Fire Brigade will be getting a full-time Fire Chief and part of their duties would be to conduct inspections.
- Commissioner Alexander advised there is a provincially regulated inspection program for active plants, but unfortunately this does not include decommissioned plants.

***ACTION ITEM** – CAO Boysen to follow up with the Ucluelet Volunteer Fire Brigade to determine what inspection procedures they currently have in place for the fish plants.

PUBLIC INPUT, DELEGATIONS, PETITIONS:

None

NEW BUSINESS:

- a) HAABC Annual Meeting update:
 - Draft agenda provided
 - Kevin Cortes to present at the conference. Advised the HAC Members if they had any information they would like to contribute, to contact him directly.
 - It has been confirmed the opening welcome will be done by the Yuułu?ił?ath First Nation.
 - New DFO Small Craft Harbours contact is Spencer Wright previously Claire Salvador.

*ACTION ITEM – Darcey to email the HAC Members & Council, formally inviting them to the HAABC Conference.

- b) Update on Actions from CAO:
 - Will be meeting with Spencer Wright, DFO next week in Vancouver.
 - To discuss the Harbour Master Plan & the steps needed to move this process forward.
 - Barclay Sound Adventure (The Float House Restaurant) has signed a 3-year agreement. This will be brought forward to the Harbour Authority.
 - Councillor McEwen provided a copy of the Small Craft Harbour Brochure. Staff to work with the Harbour Manager to create a new brochure for the 2019 season.

*ACTION ITEM – CAO Boysen to develop a plan moving forward on the Harbour Master Plan with DFO.

- c) Update on Actions from the Harbour Master:
 - Reflective markings around the breakwater docks

- Signage at the Japanese Dock to have customers be aware and courteous of the neighbourhood around them, especially with noise and lights.
- We have not received the payment from the Lawyer of the Astral Blue yet.
- There are rotten bull rails around the upper Whiskey Dock.
- The reconfiguration plan for the Whiskey Dock is in progress and is with Herold Engineering.
- Working on the presentation for the HAABC Conference, to connect with the Historical Society for additional content.

d) Other Updates:

Commissioner Alexander –

- Discussed the idea of having a fisherman's dock with fish sales for the general public.
- CAO Boysen advised this has been discussed with the Planning Department. Nothing official at this point.
- Commissioner Kimoto would prefer to see is in the Inner Boat Basin but noted he has tried selling to the public but has had better luck selling to Chefs directly.
- Kevin noted that while he is in favour of this concept, most boat owners don't live here and tend to off-load and leave right away.

Councillor McEwen –

- Noticed the carved wooden sign at the Small Craft Harbour is back up, but questioned why it was so low to the ground. Kevin advised that is where the Public Works crew decided to hang it. Commissioner Kimoto agreed that it should be higher up.
- e) Changes to Community Groups Council Liaison:
 - Councillors are no longer appointed to attend community group meetings. Shift in styles as community groups now encouraged to come to Council with correspondence, delegation requests, requesting letters of support, applying for grant in aid for a specific project, etc.
 - New terms of reference, currently in the draft form and will be presented to Council for them to review, then post a call for members.
 - Calling it a committee now instead of commission.
 - Hope to do this all before the Harbour Authority meeting and the HA will appoint the new members of the Committee.
 - Next HA meeting is February 19, 2019 at 4:30 PM.
