- 7.1 Mayor Noël noted:
 - Steve Lang's retirement from the District of Ucluelet and thanked Steve for his years of service.
 - Kennedy Flats Annual Back Roads Clean Up on December 7th was a great success, thanked all those who took part.

8 PUBLIC INPUT, DELEGATIONS & PETITIONS

8.1 Public Input

<u>Dan Vedova</u>, resident, noted that the province should be patrolling the areas where the back road cleanup occurred, as it falls in their iurisdiction.

He also commented on the temporary use permit (Agenda Item No. 13.2) being brought before Council, and noted the following:

- He lives across the street from the Thorton Motel and noted that the management of tenants is difficult given the landlord tenants act and referred to the difficulties at the Ucluelet Lodge.
- There are no cooking facilities on site so outdoor cooking may become an issue.
- He is concerned about the possible occurrence of parties and how they will be monitored and controlled.
- That if granted this permit will further limit the supply of tourist accommodation.
- That three years is a long temporary use permit.

8.2 Delegations

Rebecca Hurwitz, Clayoquot Biosphere Trust (CBT) Re: Ucluelet Community Fund

Rebecca Hurwitz, CBT, presented a slideshow, highlights included:

- Possibility of creating a Ucluelet Community Fund, including the fund structure and how it could contribute to Ucluelets' priorities.
- Funds would be pooled with other endowment funds, in fossil fuel-free investments with earnings returned to the District.
- Tofino used a similar tool to create a legacy fund for Councillor Dorothy Baird, combined with funds from Tourism Tofino.
- Noted that the fund is unique tool for philanthropy, and can be set up to be used in the case of disaster emergency response.

Council questions and comments:

- Are funds from different sources kept separately within the fund to track earnings? Ms. Hurwitz noted that funds from different sources are accounted for separately.
- Interest would be given annually? Ms. Hurwitz responded that yes it is returned if requested.
- Can spending of funds be overseen by Council? Ms. Hurwitz answered that it can be.

Marcie Dewitt, Alberni Clayoquot Child Care Action Plan Team Re: Alberni Clayoquot Child Care Action Plan

Marcie Dewitt presented a slideshow, noting that this project included a(n):

- Inventory of child care spaces.
- · Policy, plan and bylaw review.
- Regional parent survey presented which relied on anecdotal evidence.
- Early Childcare Education sector survey presented with anecdotal evidence.
- Interviews, focus groups and open houses.

Ms. Dewitt noted the following key findings:

- Top space needs are in infant/toddler & before/after school care.
- Options for parents when and where they access child care is important.
- Child care has a tremendous economic impact on families and communities.
- There is a early child care and education sector staffing crisis

where workers are not sufficiently valued or compensated for the work performed.

Council questions & comments:

 Would it be helpful for Staff to write a letter of support for the 10 dollar-a-day childcare program to the local MLA and MP? Ms. Dewitt answered that it would be helpful.

Bob Hansen, WildsafeBC Pacific Rim Re: Program Update - Support Request

Bob Hansen presented a slideshow, noting the following highlights:

- Reports of bears in residential areas are way up this year, particularly in November, probably due to great fruit yields and historically low chum salmon run numbers.
- Multi-pronged approach to engagement includes door to door bin tagging, and securing commercial bins with chain/carabeener.
- Plans for fruit gleaning and and electric fence loaner program to start next year.

Council questions & comments:

- Noted that 9 bears were shot and killed this year and asked where that occurred? Mr. Hansen answered 1 in Ucluelet, 2 in Millstream, 1 Ittatsoo, 2 Tofino, 2 or 3 in Ti-Histanis.
- Asked why we don't here about the bears being destroyed? Mr.
 Hansen noted this information has been published in the
 Westerly news as well as on his social media accounts.
- Is funding secured for 2020? Regional District has put in a request to provide 5 year funding for this program which would cover a portion of operational cost. The remainder will be raised through partnerships.
- Do you test electric fences? Mr. Hansen answered that he has done testing on a number of occasions for residents.

Bruce Greig, Manager of Community Planning

Bruce Greig, Manager of Community Planning, presented this report. He noted the following:

- That this matter is about detached cottages and a development variance permit.
- This is a relatively large property.
- The proposed bylaw does not create a community wide amendment but could be seen as a pilot project.
- Council could consider what name they would like to apply to the particular type of accessory dwelling unit, i.e. coastal cabin, surf shack etc.
- That the applicant may not be present.

Council questions & comments:

- Noted that this is for long term rentals only and asked how this is policed? Mr. Greig answered that the short term rental is not allowed on properties with this type of zoning. He further noted that they actively monitor these types of rentals and the bylaw officer is responsible for this.
- Noted that the garage space is larger than the dwelling space and asked if there is a potential for the garage space to be split and become another dwelling? Mr. Greig answered that the bylaw would not permit a second dwelling unit and further noted that conversion of the garage would require a building permit.
- Noted that they want to see more of these secondary dwellings and it is possible and necessary trend.

13.2 Temporary Use Permit - 1861 Peninsula Road Bruce Greig, Manager of Community Planning

Bruce Greig presented the report. He noted the following:

- The purpose is to allow a motel to be used for long term staff housing, which is longer than the 30 days currently allowed under the property's motel zoning.
- Conditions such as onsite manager, no cooking on hotplates and regular fire inspection apply as well as others outlined in report.
- Notice requirement has been met and it is appropriate to receive public input today.

Council invited the applicants to speak.

Dave Dawson, General Manager for Pacific Seafood Canada, which operates Ucluelet Harbour Seafoods spoke to the application. He noted the following:

- There is area near the laundry room, located near the rear of the building, which will be turned into a kitchen area for residents.
- It has been difficult finding suitable sewage treatment as well as finding people who want to live in trailers at the TRAPPA site (which the Applicant has a temporary use permit to use for employee housing).
- The applicant is recruiting workers from east coast of Canada.

Jonathan Cross, YFN, spoke to the application. He noted the following:

- The property has not been commercially successful as they hoped, and they have been exploring options for the property, including sale of the property.
- Pacific Seafood Canada's proposal for investing in the property is a very positive arrangement for YFN.
- Detailed the different types of accommodation that are available on the property including a small house and building with two bedroom apartments.

The Public was invited to speak.

Public questions & comments <u>Matt Harbidge</u>, resident, asked how parties and noise complaints will be handled? Mr Dawson answered that there will be an onsite manager

who will handle these issues if they occur.

<u>Dan Vedova</u>, resident, noted the importance of maintaining trees as a buffer to the site as well as the importance of regular inspections and strong management who are able to evict non-compliant residents.

Council questions & comments:

- Noted that as this is a temporary permit which can be rescinded if permit conditions are violated.
- Asked if there would be storage for gear? Jonathan Cross, YFN, noted that gear would not be stored in any locations visible from the property's exterior.

Ms. Monteith presented a slideshow on Municipal Budgeting Process, highlights included:

- Reserve Funds Objectives
- Tax Allocation to Classes

Council questions & comments:

- Are Barkley Community Forest funds part of the statutory reserve fund? Ms. Monteith answered that those funds are not in a statutory reserve fund but Council will need to approve expenditures from that fund.
- Does Seaview Senior's Housing Society qualify for a Permissive Tax Exemption? Ms. Monteith answered that it currently doesn't and Council noted that they would like Staff to investigate a permissive tax exemption for this society.

7.2 Overview of Strategic Plan Projects Mark Boysen, Chief Administrative Officer

Mr. Boysen presented a slideshow on the Strategic Plan, noting that staff use this plan to prioritize projects and related work, some highlights included:

- Bylaw and Policy Gap Analysis is underway.
- Housing Needs Assessment is scheduled to for 2020.
- Health Centre, Amphitrite Lands and Harbour Master plan are moving forward.
- Public Realm Project which includes Peninsula Road Corridor and Village Green.
- Utility management will include a Roads Master Plan, lighting systems and sidewalks.
- Development Cost Charges (DCC).
- Alignment of Strategic Plans Collaboration Model
 - Joint Council Meeting scheduled for January 20th, currently in the process of confirming 3-4 key topics, one of which could be Regional Planning initiatives.
 - Two Joint Council Meetings per year could be a positive outcome of this initial meeting.

- Asset & Infrastructure Management Updates
 - Noted facility assessment has been completed, which include both inventory and condition assessments. This data will be reviewed, analyzed and assessed by Staff in light of programming and use analysis to present a full picture so Council can consider future investments in facilities.
 - Noted it can take years to develop a robust asset management system and plans to provide a detailed summary in March 2020.
- Mr. Boysen noted that Barkley Community Forest Funds this can be brought forward for further discussion if any items were to be reconsidered or added to the list for 2020.

Council questions & comments:

- Mayor Noël noted that a committee originated and based here on the west coast may better represent west coast interests.
- Councillor McEwen noted that funds could be available through Community to Community Grants for community collaboration.
- Councillor Cole asked for the facility assessment to be forwarded to her? Mr. Boysen noted that he would provide the assessment to Council for their confidential review.
- Council recommended that a community fund be be brought back for discussion in January as a possible budget item.
- Councillor McEwen asked if the Historical Society funding is intended for a museum? Mr. Boysen noted that it is not allocated to a specific project at this time, though Council has written a letter of support for the museum.
